

INTERNATIONAL BUSINESS' GUIDE TO CHOOSE A QUALITY JOURNAL

JOURNAL QUALIFICATION PROCESS

The following policies define which journals are acceptable as to meet the PRJ requirement in the Faculty Qualification process for the IB faculty that teaches at the PhD Program.

1. JOURNAL QUALIFICATION PROCESS (PH.D. LEVEL)

The PhD program offers two disciplines: Finance and International Business (IB). Separate faculty groups primarily teach each area. Each of these two faculty groups developed and approved a set of criteria to select qualified journals of high quality and impact. These criteria take into account highly ranked journals in the ABDC and ABS lists as well as the *top* relevant journals in LATAM.

Faculty members who want to modify a IB-PhD journal list can petition the director of the Graduate School of Business (EGAE). The director of the EGAE will submit change requests to the faculty in the specific area for a decision. A simple majority of the faculty in the area must approve changes to a PhD. journal list.

3. JOURNAL QUALIFICATION PROCESS (PHD INTERNATIONAL BUSINESS)

In line with the interdisciplinary characteristics of the faculty, general journal qualification criteria are in effect (instead of specific lists). Notice that while journals published in English typically focus on a subject area and publish only papers within that scope, the majority of LATAM journals are *generalist*, publishing articles in all areas of business (e.g. marketing, strategy, accounting, finance, operations, ethics...).

The aim of these policies is to promote research of high quality and impact while simultaneously considering the diversity of interests and methods of the IB Faculty.

Because the list changes periodically, it is the professor's responsibility to save a print screen of the journal qualification list immediately upon submission.

(Only for Journals that do not appear in the previous three lists)

FOR LATIN AMERICAN AND CARIBBEAN JOURNALS (INCLUDES ALSO JOURNALS PUBLISHED IN ENGLISH AND FRENCH)

EQUIVALENT TO CATEGORIES A AND A * (ACCORDING TO RPAP CRITERIA, THESE ARE "OUTSTANDING" PUBLICATIONS)

Listed in the Latindex- Catalogue (https://tinyurl.com/latindex) and has an h5-index of 5, 6, 7, 8 or 9.

AND

4. the journal has an ICDS (Secondary Composite Index Broadcasting) **GREATER than 6.50** according to the Information Matrix for the Analysis of Journals (MIAR): *http://miar.ub.edu/search*

EQUIVALENT TO CATEGORY B (ACCORDING TO RPAP CRITERIA, THESE ARE "TOP" PUBLICATIONS)

Listed in the Latindex- Catalogue (https://tinyurl.com/latindex) and has an h5-index of four **4** OR Ranked in the top 25 in the study by Ruiz-Torres et al. (2012, See Appendix 1) OR Ranked in the top 15 in the study by Olavarrieta (2016, See Appendix 2).

2. The journal has an ICDS (Secondary Composite Index Broadcasting) **EQUAL or SMALLER than 6.50** according to the Information Matrix for the Analysis of Journals (MIAR): http://miar.ub.edu/search

EQUIVALENT TO CATEGORY C (ACCORDING TO RPAP CRITERIA, THESE ARE "GOOD" PUBLICATIONS)

Listed in the Latindex- Catalogue (https://tinyurl.com/latindex) and has an h5-index of four **4** OR Ranked in the top 25 in the study by Ruiz-Torres et al. (2012, See Appendix 1) OR Ranked in the top 15 in the study by Olavarrieta (2016, See Appendix 2). **AND**

2. The journal has an ICDS (Secondary Composite Index Broadcasting) **EQUAL or SMALLER than 6.50** according to the Information Matrix for the Analysis of Journals (MIAR): http://miar.ub.edu/search

SCHOLARLY BOOKS' CATEGORY* (ACCORDING TO RPAP CRITERIA, THESE ARE "GOOD" PUBLICATIONS) Scholarly books, monographs or publications by a major publisher.

These publications do not replace FAE's qualification requirement of two peer-reviewed journal publications to teach at Ph.D. level.



4. IMPORTANT INFORMATION

The international business criteria to choose a journal applies to professors that are teaching PH.D. Program's IB courses.

These selection criteria may also apply to professors that are teaching PH.D. Program's core courses required for students from both areas (IB and finance).

Professors that teach finance courses must follow finance criteria to choose a journal.

4. EXCEPTIONS AND FACULTY REQUESTS

To concede exceptions to any of these policies requires approval on a per article basis. Faculty should make a written request to their department director, including the justification for the selected journal and its relevance to the research focus or discipline. The Director of the Graduate School and the Dean would make determinations on these requests.

No more that 10% of the five (5) year period journal publications should fall within this category.

No exceptions will be granted for journals considered predatory/ unethical as described in Section

6. REVISION TO THIS DOCUMENT

Every five years (during the second semester) the IB Faculty, the Director of the Graduate School, The Dean and the Accreditation Office will collaborate revising this document, its policies and procedures.

8. WHERE NOT TO PUBLISH

The importance of publications in the academic world has led to the growth of predatory publishers. These organizations typically offer rapid publications, have low standards/ quality and charge significant fees for publication. These publishers typically report false impact factors and indexing. Articles that appear on journals published by the organizations will not be counted towards the SA/SP qualification.

Furthermore, the importance of citations has led to the practice of journal self-citations (journals encourage authors to cite multiple past articles from the same journal). This practice artificially inflates a journal's citation and does not represent a quality journal. Thomson Reuters, who is one of the flagship organizations in regards to citation reports, provides a list of journals that have been "tagged" for excessive self-citations
